### "No" to Phone Tower at Ocean Shores

On 5 February Byron Shire Council voted unanimously to reject a proposal by Telstra, Australia's largest telecommunications company. The document sought approval to lodge a development application to erect a 30 metre high tower on Council-owned land. It was worded as an "agreement in principle", a tactic perhaps intended to lock Council in to accepting the project in whatever final form was to be presented.

The community successfully raised concerns regarding visual amenity, fire hazard and loss of property value. Added emphasis was placed upon documented health risks since the tower would have been within 300 metres of dozens of private homes and two schools. The latter is against the Department of Education's own guidelines which specify a minimum 500m buffer. In response to a question from Council, the Telstra spokesman was unable to assure that there were no adverse biological effects from the expected level of microwave radiation. He also stated the tower would be 4G, when it was described as 3G (CDMA850) in the proposal drafted by their agent Aurecon. The former is capable of multi-band and much higher outputs. The Telstra rep was given a copy of our DVD for future reference.

Congratulations to our nine Councillors for taking a stand against corporate expediency, and requesting Telstra to find a more remote site. It will probably cost them more. But why should private citizens be expected, through loss of value on their property, to effectively subsidise a multi-billion dollar corporation?

One week prior to the vote, a protest meeting at the Ocean Shores Public School was attended by nearly 150 parents and residents. Petitions presented to Council contained in excess of 700 signatures. In addition to expert speakers on the night, a member of our group narrated a slide show on the operating principles and impacts of phone towers.



All-in-all, this campaign was one of the best organised and resourced we have seen to date. Its success perhaps also benefited from our engagement with Council over the past two years on similar matters. Any readers who are presently opposing a phone or NBN tower in their area and would like to draw upon our experience, are invited to send an introductory email.

#### **Tower Curiousities**

There is perhaps another reason why Telstra lodges exploratory DA's in advance of submitting a complete one. They can thus avoid any potential rejections of the latter, and thereby claim a low failure rate for attempted tower sitings. For example, in their publication "Responsible Business, Conducting Our Business Ethically", it states, "In 2012/13, Telstra completed 2,945 mobile infrastructure consultation projects of which 182 were new development applications (173 were approved) ..." This could lead one to believe that out of 182 towers only 9 experienced community opposition.


Here is an unsolicited testimonial from a person who lives near the existing tower in the nearby town of Mullumbimby NSW, "We have a tower within 500 metres of us here in Mullum. The effects have been quite debilitating, e.g. edema around my wife's eyes, tinnitus, clicking in my ears, insomnia and 12 kilos weight loss. The radiation level has about doubled since 2011 when the tower first went up. Since then more antenna panels have been added." A recent article in the local paper reported TV interference subsequent to a 4G upgrade. Telstra stated this is "being worked out", even though the issue is well known and predictable.

Some skeptics assert there is no likely health risk from microwave faciities because radio and TV towers have been around for over 50 years with no apparent ill effect. However, a number of epidemiological surveys indicate otherwise, as does the following research linking FM broadcast towers with melanoma. It should also be noted that up until a few years ago broadcast signals were analogue waveforms. 





Saddled by private sector allegiances with a scientific cover-up of Biblical proportions, ARPANSA, our official government regulator, is attempting to have a bet both ways. Their message to an increasingly bewildered public seems to be, "EMR is totally safe, but we are not totally sure so you better exercise 'precaution', whatever you think that might be." The following quotes are from their everevolving "Fact Sheets". The italicised commentary is mine.

#### Fact Sheet 14:

"However, the technology is new and it is impossible to be completely sure there isn't some risk." Whether we like it or not, everyone now consumes EMR. *Can you imagine buying a food product with this printed on its label?* 

"Due to lack of evidence on mobile an cordless phone use by children, ARPANSA recommends that parents encourage their children to limit their exposure." What about involuntary Wi-Fi exposure in schools? And why make this recommendation at all if the precautionary principle is already "enshrined" in the standard as ARPANSA claims?

"Some research has indicated that nonthermal effects from low-level EMR exposure may also occur. However, the existence of these effects and their implications has not been sufficiently established to allow for them in the standard." *Tellingly, this admission of documented non-thermal effects*  appears to have been DELETED from the current version of this Fact Sheet.

#### **Official Letter dated 20 March 2013:**

"ARPANSA does not regulate policy in the education department. It is up to schools to apply the precautionary minimisation requirement in the ARPANSA standard as they see fit." *So, is every school Principal supposed to be a microwave engineer, or is this just passing the buck?* 

#### Fact Sheet 2:

"The Standard incorporates a precautionary approach which requires owners of RF sources to minimise unnecessary exposure of the public to RF fields. Australian regulators and codes of practice will decide how this statement is applied." *In other words, just make it up as you go along and hope no one notices.* 

ARPANSA takes its cue from the World Health Organisation, which takes its cue from the industry body ICNIRP; the "Tobacco Institute" of EMR. However, during a meeting in 2008 at the Royal Society in London, ICNIRP's then head, Professor Paolo Vecchia, cautioned the following about their published "exposure guidelines".

- They are not mandatory prescriptions for safety ...
- They are not the last word on the issue ...
- They are not defensive walls for industry or others ...



### The NBN\* - A Loose Canon?







\*National Broadband Network. Fixed Wireless Internet and the blurred reality of industry codes of practice.

One of our contacts has attempted to pin down the regulatory regime under which NBN Co. operates. Here is a brief summary of his findings so far.

"NBN is in our midst proposing to erect microwave towers. What controls are there on NBN's actions? Through careful wording, NBN avoids being limited by the Telecommunications Code of Practice (C564 2011), as this relates specifically to phone towers. The Australian Communications and Media Authority (ACMA) website advises that NBN is voluntarily complying with the Code. This is denied by NBN.

The approvals for the sites involving microwave towers ("high impact" facilities) is totally covered by Local Council under its Development Approval (DA) process within the Planning Scheme, and perhaps also the State. The ACMA has no involvement, and does not not even want siting criteria from NBN. After a tower is in place then another telecommunications group can install up to an additional 5 metres of tower and further antennas ("low impact" facility) without any additional approval.

We must therefore be aware of what approval is sought and what approval is given. NBN has to calculate its radiation patterns and submit this with any DA. But this is only part of the story. Up to 500 rooftop antenna, linked to any single tower, can be installed to service subscribed households. Large segments of the population are thereby involuntarily exposed to microwave transmissions. This is integral to the total system being installed by NBN under its Spectrum License. We need to understand that there is limited control over NBN and ask why this is justified."



Join the Australian Communications Consumer Action Network (ACCAN)?

The following email was received from another long-time campaigner against NBN wireless towers.

"In the middle of last year, I found an organisation https://accan.org.au/about who were very interested in my activities and because they meet with Telstra, NBN Co and the government. I asked them to find out a few things for me. They did and their response sparked off the Commonwealth Ombudsmen investigation for the first time into the Department of Communications. I was not a member of ACCAN at the time, nor am I now (yet).

Recently identified have been the working papers of The Communications Alliance Ltd. in relation to NBN Co. They appear to be the true architects of the beast. They also fund "research" into wireless and ensure ARPANSA give their funded research glowing accolades; coincidentally ignoring or smearing independent studies. ARPANSA names The Communications Alliance on their website as contributor to on-going research studies.

Having found their deep involvement in NBN Co, possible political donors, and also one of the most powerful industry lobby group alliances in the country, we need to step it up beyond mail outs and Facebook Pages. I think we should join the ACCAN and use it's infrastructure to highlight the NBN Co. issues, and organise en masse campaigns on the injustice of consumers reportedly being coerced into migrating to NBN Co. products.

ACCAN asked Combined Pensioners & Superannuation Association of NSW to make a submission to the Communications Alliance who are preparing to REMOVE THE CONSUMER PROTECTIONS CODE to coincide with the mass migration to NBN infrastructure. Not only is it despicable to remove protections from the vulnerable members of our communities, but why does our government permit this company to maintain that Code anyway? http:// www.commsalliance.com.au/\_\_data/ assets/pdf\_file/0004/46669/Combined-Pensioners-and-Superannuants-Association.pdf

Accordingly, I propose that joining the ACCAN MIGHT be a first step to influencing a powerful response to NBN Co. & the Alliance. Please watch the NCNBNTAG Facebook Page for collated response."





The presumed objective is to ease the load on their heavily promoted 4G data network, and appears to be aimed at infrastructure cost savings. ### Wi-Tricity - Wireless Electrical Power

This technology relies upon beaming enough raw EMR through your living space 24/7 to remotely power standard electrical appliances like lights, laptops and TV's. obviously, the ambient field intensities required are far higher than of data modalities such as domestic Wi-Fi or Bluetooth. Although the system operates well below the microwave range, one might wonder about the adequacy of current safety standards to keep abreast of such new developments.


