



NBN recently completed an EME report for a wireless internet tower to be constructed at 261

Settlement Road, Mullumbimby NSW. At the time of this writing, no development application has been lodged with Council. Residents in the area seeking further information on how these facilites may affect general wellbeing, visual amenity and property values, or who wish to organise opposition, are invited to contact us at the earliest.

Sunshine Coast Area

Due to objections lodged by a well-run opposition, Sunshine Coast Council has, on the following grounds, refused a DA for an NBN tower at Hunchy QLD.

1. The proposed development conflicts with the Strategic Framework of the Sunshine

Coast Planning Scheme 2014 in regard to visual amenity impacts;

2. The proposed development conflicts with the Purpose and overall outcomes and the

Performance Outcomes of the Scenic amenity overlay code;

3. The proposed development conflicts with the Purpose and overall outcomes and the

Performance Outcomes of the Telecommunications facilities code.

There are a number of other towers proposed

for the same region, including one at Beerwah where a "public information" event was held by NBN on 2 September. A local paper quoted an NBN rep as stating, "Based on the feedback we received residents are largely supportive of the fixed wireless network proposal". However, reports from the Maleny group's display outside hall was that up to 50% of locals were dissatisfied with NBN's presentation.

According to one member. "This is the NBN pattern. They hold information meetings, sometimes as much as 20 to 30 minutes drive away from the proposed tower site (as happened in the case of the Hunchy Road site) and then issue glowing reports of the popular support based on nothing. In NSW one town of 350 people petitioned with 96% of the town opposed to the NBN tower, but NBN reps told local Council that there was 'overwhelming support' for their proposed tower."





Enova Community Energy Ltd. is seeking to establish locally-generated electicity networks in Northern Rivers region of NSW. http://www.enovaenergy.com.au/. We contacted them by email to inquire to what extent smart metering and wirelessly linked appliances might be utilised. Here is their reply.

Re: smart meters. We will contract with a meter provider and data agent to provide this service. They also determine the comms. Keeping in mind that smart meters are optional for our target market. Re: smart appliances. Our primary area for focus will be solar and battery. This usually uses the customers internet/wireless. But it is too early to know exactly what comms we will need. We are talking to a data provider in relation to this, so it will probably use whatever they use for comms as they are the service provider. I will have a better idea once we have determined our product requirements and how heavily this relies on comms.







Commentary, with implied reference to electrosensitivity, on the UN Convention on the Rights of Persons with Disabilities.

Without accessible transport to schools, accessible school buildings, and accessible information and communication, persons with disabilities would not have the opportunity to exercise their right to education (art. 24 of the Convention). Thus schools have to be accessible, as is explicitly indicated in article 9, paragraph 1 (a),

of the Convention.

However, it is the entire process of inclusive education that must be accessible, not just buildings, but all information and communication, including ambient or FM assistive systems, support services and reasonable accommodation in schools. In order to foster accessibility, education as well as the content of school curricula should promote and be conducted in sign language, Braille, alternative script, and augmentative and alternative modes, means and formats of communication and orientation (art. 24, para. 3 (a), with special attention to the appropriate languages and modes and means of communication used by blind, deaf and deaf-blind students. Modes and means of teaching should be accessible and should be conducted in accessible environments. The whole environment of students with disabilities must be designed in a way that fosters inclusion and guarantees their equality in the entire process of their education.

Full implementation of article 24 of the Convention should be considered in conjunction with the other core human rights instruments as well as the provisions of the Convention against Discrimination in Education of the United Nations Educational, Scientific and Cultural Organisation.
